

CONVENTION

By this Convention, including:

- the Italian Federation of Sport Fishing and Underwater Activities based in Rome Viale Tiziano n. 70, in the person of its President and legal representative pro tempore, Prof. Ugo Matteoli, hereinafter also FIPSAS, on the one hand, and

and

- A.I.D.A. Italia Associazione Sportiva Dilettantistica based in Cagno (CO) Via Bernasconi 23, in the person of its President and legal representative pro tempore, Dr. Gabriele Satto, hereafter AIDA Italy, on the other,

Granted

- a. that both AIDA Italy and FIPSAS have among their statutory objectives to promote and develop competitive apnea;
- b. that both AIDA Italy and FIPSAS have an interest in establishing between them a relationship of mutual cooperation and technical cooperation;

Given the above

it is hereby agreed as follows

Art. 1) – The premises form an integral and substantial part of this Convention.

Art. 2) – F.I.P.S.A.S. and A.I.D.A. Italy committed, as part of this collaboration, to exchange information on their initiatives to develop and enhance activities related to competitive freediving. In particular, F.I.P.S.A.S. and A.I.D.A. Italy committed to achieving mutual cooperation through the following activities and others not listed:

- a. the exchange of information and experiences for the development and management of competitive apnea in the conditions of maximum safety for the physical health of athletes;
- b. the exchange of information aimed at finding a substantial uniformity of regulations that govern competitions of various freediving disciplines;

- c. the adoption of doping controls at freediving competitions, in the manner prescribed by the CONI anti-doping rules;
- d. the exchange of information on the judges training;
- e. the exchange of information and experience in the logistical organization of major sporting events on high standards;
- f. any other activities that will be jointly decided by the respective executives.

Art. 3) – Al fine di contribuire in Italia allo sviluppo dell’Immersione in apnea agonistica, la F.I.P.S.A.S. e la A.I.D.A. Italia, nel rispetto dei rispettivi ruoli e competenze, si impegnano a:
 In order to contribute to the development of competitive freediving in Italy, FIPSAS and A.I.D.A. Italy, while respecting their specific roles and responsibilities, commit to:

- a. recognize the FIPSAS exclusivity in Italy for the organization of national and international events called "Campionato";
- b. recognize the A.I.D.A. Italy the right to organize national and international events with any word other than that of "Campionato";
- c. allow the free participation of their respective affiliates in competitions organized by both parties if the following requirements are guaranteed:
 - c1) registration procedures provided by the organizer;
 - c2) adequate security conditions to ensure the health and safety of the athletes as provided by law or the common uses of the Organization;
 - c3) the adoption of doping controls in the manner prescribed by CONI;
 - c4) in the competitions organized by A.I.D.A. Italy, the adoption of regulations possibly conform to those provided by the CMAS / FIPSAS in their various freediving disciplines, if they are not in obvious conflict with those provided by AIDA INTERNATIONAL.

Art. 4) – AIDA ITALY undertakes to promote among its members the FIPSAS membership.

Art. 5) – La F.I.P.S.A.S. e A.I.D.A. Italia si impegnano a trasmettere ai soggetti sportivi loro affiliati e ai rispettivi Dirigenti copia della presente convenzione, vigilando perché venga

rispettata. F.I.P.S.A.S. and A.I.D.A. Italy undertake to diffuse this document to their respective affiliates and executives, ensuring it is complied with.

Art. 6) – Any changes will be made in writing.

Art. 7) – La presente Convenzione decorrerà dalla data di sottoscrizione delle parti e avrà validità fino al 31 Dicembre 2012; si intenderà tacitamente rinnovata alla scadenza, salvo disdetta scritta, a mezzo lettera raccomandata A/R, da effettuarsi entro tre mesi dal termine. This Convention shall commence from the date of subscription and is valid until December 31, 2012, will be automatically renewed on expiry, unless canceled in writing by registered A/R letter, to be sent within three months from the date.
